All Exhibitors Need to Provide with Your Mailed Contract:

Copy of current NY State Sales Tax Certificate..... NY State Dept of Taxation 1-800-972-1233-Form DTF-17- If apply for a number it can take 30 days or longer to arrive.

Two Photos of items & One of booth display.....Enclose self address stamped envelope for return of photos or written confirmation. Your cancelled check is your confirmation.

SHOW RULES & REGULATIONS

A Show Entrance Card will be mailed to you approximately 10 days before the show with your area marked.

Set-up begins at 7:00 a.m to 9:00 a.m. After checking in you must drive to your space, unload and park on the nearby streets. You must be off the streets at 6:00 p.m. Late arrivals after 8:30 a. m. cannot be guaranteed their requested space & might have to dolly your items to your space. We will try our best to place returning exhibitors in their requested space.

No pets...That is a Village of Nyack law

The exhibitor must occupy only the space assigned to them; it will be marked on the street or curb.

P.J.'s Promotions has the right to prohibit conduct that it deems deleterious to the show and can remove any exhibitor that causes a disruption.

If you do not appear at the show, for any reason, you will not be entitled to a refund- show held rain or shine. No refund for inclement weather issues.

The exhibitor is responsible for the removal of their displays, booth & materials, including any trash. **ALL EXHIBITORS MUST DISPLAY THEIR ITEMS IN AN ATTRACTIVE MANNER-NO CARDBOARD BOX DISPLAYS ALLOWED. TABLES MUST BE COVERED WITH A CLOTH TABLECLOTH**

Exhibitors are solely responsible for the payment of NYS Sales Tax.

Nyack merchants participating in the Show must sell only the items regularly for sale in their shop.

FOOD VENDORS INFORMATION- All FOOD VENDORS REQUIRE A HEALTH FOOD PERMIT

It is the sole responsibility of the Food Vendor to obtain the proper permit from the Rockland County Dept. of Health. Failure to obtain the required permit will not entitle the vendor a refund.

The food permits can be obtained at the Rockland County Dept. of Health at 1-845-364-2600.

Food vendors who distribute samples must apply for a Health Food Permit also. P.J.'s Promotions will need a completed copy of all food permits submitted at least 10 days before the show.

A copy of your menu & photo of your booth must be submitted with your contract to avoid duplication.

An Insurance certificate naming P.J.'s Promotions & ACADA & the Town of Nyack as additionally insured must be sent 2 weeks prior to the show.

No noisy or noxious generators allowed, you will be asked to turn them off. All electrical wires must be contained near your booth.

Payment Methods

Prior to deadline payable in cash, check, money order or credit card (Visa/MC/Amex)

After deadline payable in cash (in person) bank check, money order or credit card only. A \$30 Bad Check Charge will be billed to you. Day of Show cash only (no exceptions)

YOUR SIGNATURE IS REQUIRED on Both Sides-UNSIGNED CONTRACTS WILL NOT BE ACCEPTED.
