The Weekend in the Park Arts & Crafts Show will be held in the large field directly behind the War Memorial Building in Jim Barnett Park, 1001 E. Cork Street, Winchester, VA. A limited number of indoor spaces are also available in the large gymnasium in the War Memorial Building. Eliminate all concerns about the weather! Indoor spaces will be assigned based on order of receipt of application (first come, first served).

PLEASE READ ALL RULES AND REGULATIONS BEFORE COMPLETING AND SUBMITTING YOUR APPLICATION.

Complete the application form in full and describe all crafts in detail, use additional pages if necessary. Due to the fact that this is a juried show, please include representative photographs of all items to be displayed in the show (no slides please). **If you wish your photos returned please include a self-addressed, stamped envelope for that purpose.** All selected applicants will be notified upon selection. Assigned spaces will be sent after April 15, 2012. The application fee and photos will be returned to all participants not selected for entry.

Past acceptance does not guarantee acceptance in this show. The decision of the Arts & Crafts Jury Committee is final.

Jurying will begin after January 1. Please be prepared to wait to hear from us. If you are accepted you will be sent an approval letter. If your application is declined, your check and photos will be returned to you. If you have not heard from us your application is pending review.

RULES & REGULATIONS

Dates: May 5 and May 6, 2012

- Ⓢ Show Time: 10 am - 5 pm (both days)
- Ⓢ Outdoor event on park grounds/Indoor Gymnasium-Jim Barnett Park, 1001 E. Cork Street, Winchester, VA
- Ⓢ Deadline for application is March 30, 2012. Jurying process begins after January 1, 2012.
- Ⓢ The event will be held Rain or Shine. Be prepared for inclement weather.
- Ⓢ Set up time will be communicated with the space assignment letter.
- Ⓢ Refunds of entry fees will be paid in full for cancellations received prior to March 30th. There will be NO refund for cancellations after March 30th.
- Ⓢ Past participation does not guarantee acceptance.
- Ⓢ Participants must be 18 years of age or older.
- Ⓢ Only ORIGINAL, HANDCRAFTED items made in the USA by the participant will be accepted.
- Ⓢ All equipment is provided by the participants. Electricity is not available at the outdoor spaces. Only whisper-quiet generators will be allowed.
- Ⓢ Commercial liability insurance is required by the Festival's organizers. Vendors who have their own policy will be asked to submit a certificate of insurance upon acceptance to this event. Vendors who do not have their own policy will be covered under the Festival's policy, but will pay a slightly higher booth fee.

This show endeavors to promote vendors selling high-quality, hand-crafted items. Some crafters supplement their stock with purchased items. Some try to pass off purchased items as home-made. This will ultimately lead to a show that is disappointing to our visitors and unprofitable to our crafters. Our policy is to refuse entry to any crafter trying to sell purchased items. Vendors displaying items not personally handcrafted will be asked to remove those items. Any vendor with a majority of buy-sell items or who argues with the committee's directives will be asked to leave the show immediately. No space fees will be refunded. Vendors who are asked about the origination of their crafts should be prepared to produce invoices documenting the purchase of the raw materials used to make their items. By signing the application you will be agreeing to the terms of this contract.
